#### Quick Books accounting software

Quick Books is an accounting software package developed and marketed by Intuit.

If you have ever purchased from Felt and been issued with an invoice then we hold some or all of the following details about you on Quick Books: name, email address, telephone number, invoice address, delivery address (if different).

Our customer data stored on Quick Books is never stored on the Cloud and is never shared online over the internet. It is backed up regularly to a secure external hard drive that is kept under lock and key.
